**FEE DETAILS TO BE DEPOSITED BY THE SELECTED CANDIDATES without late fee**

1. Fees of **Rs. 51,695/-** +Rs. 3000/- Late fee **Rs. 54,695/-**(Candidates who have passed 12<sup>th</sup> class from CBSE, Haryana School Education Board, Punjab School Education Board, Himachal Board and ICSE Board) and **Rs. 52,195/-** + Rs. 3000/- **Late fee Rs. 55,195/-** (Candidates who have passed 12<sup>th</sup> class from other University/councils/Boards except CBSE, HPEB, PSEB, ICSE and HSEB)) in favour of the Registrar, Panjab University, Chandigarh.
2. Rs. 9550/- as department funds to be paid by all selected candidates (Director Law SSGPURC) **later on.**

**Fee for Scheduled Caste students of Punjab State only who are eligible for Post Matric Scholarship (i.e. whose family income is less than or equal to 2.5 lac from all sources) required to deposit the fee as per the following :**

1. Fees **Rs. 12924/-**+ Rs. 3000/- Late fee **Rs. 15,924/-** (Candidates who have passed qualifying examination from **P.U. Chandigarh**) and **Rs. 13,424/-**+ Rs. 3000/- Late fee **Rs. 16,424/-** (Candidates who have passed qualifying examination **other than Panjab University**) in favour of Registrar, Panjab University, Chandigarh.
